### Notice

The Applicants for Combined Higher Secondary (10+2) Level Examination, 2022 may kindly note the **Dates of 'Window for Application Form Correction' and online payment of Correction Charges as 09-01-2023 to 10-01-2023(23:00)**. Hence, applicants are advised to cross check their applications and utilize the 'Window for Application Form Correction' if any corrections are to be done.

2. In this regard, applicants of above said Examination are advised to go through the provisions of the Examination Notice especially w.r.t Photograph & Signatures and to ensure that proper photo & signature are uploaded during online Application.

**Some of the important Provisions w.r.t Photograph/Signature are also given below: -**

10.2 In the online Application Form, candidates are required to upload the scanned colour passport size photograph in JPEG format (20 KB to 50 KB). Image dimension of the photograph should be about 3.5 cm (width) x 4.5 cm (height). In compliance of the Order dated 05.03.2020 of Hon'ble Supreme Court in the matter of Shantanu Kumar & Ors. [Writ Petition (C) No.234 of 2018], the photograph of the candidate should not be more than three months old from the date of publication of notice of the examination. **The Photograph should be without cap and spectacles. The frontal view of the face should be clearly visible.**

10.3 Before submitting the Application Form, candidate must ensure that the photograph is uploaded as per the given instructions. If the photograph is not uploaded by the candidate in the desired format, his application/ candidature will be rejected or cancelled. **Specimen of photographs delineating photograph acceptable/ photograph not acceptable is also given at Annexure-V.**

15.11 Applications with **blurred photograph and/ or signature** will be rejected.

1.b. of Annexure-IV Scanned signature in JPEG format (10 to 20 KB). Image dimension of the signature should be about 4.0 cm (width) x 2.0 cm (height). **Applications with illegible/ blurred signature will be rejected.**

3. **Persons with Benchmark Disabilities (PwBD) candidates: -**

With reference to earlier Examination Notices, it has been noted that Persons with Benchmark Disabilities (PwBD) candidates are mentioning wrong category of their Disability. Therefore, they may ensure to select the benchmark disability category exactly as per their category certificate at **Sl No. 9; Sl No. 9.1 and at Sl No. 19.1 to 19.5** of the application form. **If the Applicant choose the wrong Disability Category, he/she will not get the benefit of his selected category.**
