### Notice

The Applicants for Multi-Tasking (Non-Technical) Staff, and Havaladar (CBIC & CBN) Examination, 2023 may kindly note the **Dates of 'Window for Application Form Correction' and online payment of Correction Charges as 26-07-2023 to 28-07-2023(23:00)**. Hence, applicants are advised to cross check their applications and utilize the 'Window for Application Form Correction' if any corrections are to be done.

**2. Uploading of proper Photo & Signature:-** With reference to earlier Examination Notices, it has been noted that candidates are uploading **Photographs (which are blur , miniature, photo with Spectacles/Hat/Cap, facing sideways, etc)** and **Signatures (which are miniature, blur, illegible etc)** that are not acceptable as per provisions of the Examination Notice resulting in the rejection of such applications. Therefore, applicants of above said Examination are advised to go through the provisions of the Examination Notice especially w.r.t Photograph & Signatures and to ensure that proper photo & signature are uploaded during online Application.

**3. Persons with Benchmark Disabilities (PwBD) candidates:** - With reference to earlier Examination Notices, it has also been noted that Persons with Benchmark Disabilities (PwBD) candidates are mentioning wrong category of their Disability. Therefore, they may ensure to select the benchmark disability category exactly as per their category certificate. If the Applicant choose the wrong Disability Category, he/she will not get the benefit of his selected category.

**4. Persons with Disabilities (PwD) candidates:-**The facility of scribe/ compensatory time is being provided to PwD candidates having disability less than 40% and having difficulty in writing in pursuance to OM No. 29-6/2019-DD-III dated 10.08.2022 issued by Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment. These candidates have to indicate "Yes" against Sl. No. 18.3 of the application form. However, such candidates will also have to produce the certificate from competent authority as per format at Annexure-IA to the Notice of Examination to avail facility of scribe/ compensatory time.

As it is noted that normal candidates are also mentioning as "Yes" against Sl. No. 18.3 and at later point requesting to modify their application form, normal candidates are requested to be cautious in this regard. (Ref 8.3 of the Notice for more information)

**5. Mentioning of proper Category(SC/ST/OBC/EWS/ESM):-** Candidates are cautioned that they must ensure that they belong to the category as filled in the application form and are able to prove the same by furnishing the requisite certificate from the competent authority when such certificates are sought by concerned Indenting Departments/ Organizations at the time of document verification, failing which their candidature will be cancelled.
