Important Instructions:

- 1. You should report for DME at 08.00 AM on the allotted date at the above venue, failing which you will not be admitted to DME.
- 2. DME is the Sole responsibility of the CAPF (CRPF).
- 3. You will not be admitted to the DME without producing this Admission Certificate.
- 4. You should bring 04 copies of your latest colour passport size photograph and photo-bearing I/D proof in original for verification of identity.
- 5. In case you are seeking relaxation in height and chest on account of being belonging to areas mentioned in para11 A of the Notice, you should produce the required Certificate as published in the Notice of the Examination.
- 6. Details of Medical Standards are mentioned in paragraphs 11 C, and 11 D of the Notice.

- 7. Candidates, who are found to be unfit, will be informed of the position on the day of DME and they can make an appeal before Review Medical Board within the prescribed time limit of 15 days. Decision of Re-Medical Board/Review Medical Board will be final and no appeal/representation against the decision of the Re-Medical Board/Review Medical Board will be entertained.
- 8. Your candidature is PROVISIONAL. You must therefore ensure that you fulfill all the conditions of eligibility including the Essential Qualifications as laid down in the Notice of the examination. If at any stage it is found that you do not fulfill any of the conditions of eligibility, your candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that you have been called for DME does not confer any right to be treated as eligible for appointment. To avoid any disappointment at later stage, you are advised to recheck whether you meet all the eligibility criteria laid down on the crucial date prescribed for the post/examination in question.
- 9. The clause regarding admissibility of 'tattoos' are clearly mentioned in Para No 11 E of the Notice as below:
 - (i) <u>Content:</u> Being a secular country, the religious sentiments of our countrymen are to be respected and
 - thus, tattoo depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
 - (ii) <u>Location</u>: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non saluting limb or dorsum of the hands are to be allowed.
 - (iii) <u>Size:</u> Size must be less than ¼ of the particular part (Elbow or Hand) of the body.
 - (iv) For Sub-Inspector in Delhi Police, above clauses on tattoo are not applicable.
- 10. Ex-Servicemen must pass the medical standards prescribed for direct recruits.
- 11. No travelling or other expenses will be paid for attending the DME to any candidate.
- 12. Candidates may come prepared to stay till the completion of the DME. SSC/CRPF will not provide any lodging/boarding facility.
- 13. You should abide by the instructions of the authorities at the DME venue. Any act of indiscipline may result in rejection of your candidature.
- 14. Canvassing in any form will result in cancellation of candidature.
